AUCTION OF GOVERNMENT OWNED PROPERTIES

A Golden Opportunity to Purchase / Invest and Avail Benefits and Reliefs offered for the Construction & Real Estate Sectors by the Government of Pakistan

- Ideal time to invest in view of Prime Minister's Tax Relief /incentive package for Builders and Developers:
 - Offers Immunity to any person from probe regarding the Source of Investment:
 - With respect to amount invested (**between 17 April 2020 to 31 December 2020**) as capital in Building or Land subject to certain conditions
 - To the first purchaser of a Building or a unit purchased from a Builder in respect of purchase price (**may be settled up to 30 September 2022**) of the Building or Unit
 - To the purchaser of a Plot (**purchased between 17 April 2020 to 31 December 2020**) who intends to Construct a Building thereon subject to certain conditions
 - Introduces Fixed tax to the income and gains of any Builder or Developers to be calculated on the basis of area of a project
- Exempts Dividend Income out of the Profits & Gains of project of a Builder or a Developer, registered as a company
- Exempts the Eligible projects of Builders and Developers from turnover tax
- Exemption to Builders and Developers from withholding of taxes on building materials and services, subject to certain conditions
- Reduces rate of advance tax to only 5% on sale proceed of immovable property through Auction
- Reduction in Stamp Duty / Taxes by Provincial Governments

- Privatisation Commission invites interested individuals, firms and companies not owned by the Federal Government, both local and foreign, to participate in the auction for sale of the properties mentioned herein, owned or controlled by the Ministries/Divisions/Entities of Federal Government on 'as is where is basis'.
- Bid Documents can be downloaded **FREE OF COST** from Privatisation Commission official website (www.privatisation.gov.pk). If still needed by any bidder, printed Bid documents can be purchased from Privatisation Commission during office hours against fee of PKR 1,000/- paid either through Cash Deposit Bank Slip or in shape of Call Deposit/Bank Draft/Pay Order issued by a scheduled bank in favor of Privatisation Commission. Bid documents will also be available for purchase at auction booth to be established at the venue on the day of auction on payment of mentioned amount.
- A request for courier of Bid Documents can also be made by sending application to the addresses mentioned below, accompanied with fee of PKR 2,000/-, paid either through Cash Deposit Bank Slip or in shape of Call Deposit/Bank Draft/Pay Order issued by a scheduled bank in favor of Privatisation Commission of Pakistan.
- Persons residing outside of Pakistan can also request for Bid Documents through courier against wire transfer fee of PKR 10,000/- in below mentioned bank account of Privatisation Commission of Pakistan.

Facilitation to Interested Bidders:

- Bidders can download **FREE OF COST** information memorandums of each property, incorporating details, salient features, location and potential.
- Information of each property, bidding process, terms & conditions etc. are available for **free download** from www.privatisation.gov.pk
- If requested, Interested bidders will have the opportunity to visit the property site on a working day, as specified in Bid Documents.

Other Conditions:

- Auction shall be held as per terms and conditions referred in the Bid Documents.
- Earnest Money equal to 10% of Reserve Price mentioned in this advertisement for each property shall be in shape of a call deposit, bank draft or pay order issued by a scheduled bank in Pakistan or in cash if the property reserve price does not exceed PKR. 5,000,000 and shall be submitted at the Auction Booth at the time of registration of bidders for respective property, along with other required documents as detailed in Bid Documents.
- Successful bidder will have to deposit 30% of accepted highest Bid Price within seven (07) calendar days of Letter of Acceptance issued.
- Balance 70% of accepted Bid Price (less the Earnest Money) will have to be deposited within thirty (30) days of issuance of the Letter of Acceptance in case of properties listed at serial numbers 1-19 and 22-26. For properties listed at serial numbers 20, 21 and 27 this balance payment will have to be deposited within Sixty (60) days of issuance of the Letter of Acceptance.

- The default in timely periodic payments due by the successful bidder, shall entitle the Commission to forfeit the Earnest Money and deposited amount.
- Earnest Money will be refunded to unsuccessful bidders (without any profit, mark-up or interest etc., thereon) within the period as mentioned in the Bid Documents.
- Advance income tax @ 5% (from filers) and 10% (from non-filers) will be collected as per Section 236A of the Income Tax Ordinance, 2001.
- All applicable Federal, Provincial and Local fees, taxes and levies regarding transfer of property will be paid by the successful bidder.
- Privatisation Commission reserves the rights to accept or reject all or any of the bids at any stage without assigning any reason thereof.
- SOPs as announced by the Provincial/Federal Government for public gatherings will have to be followed by the bidders on the auction day at the referred venues.
