## **INVITATION FOR BID**

## DESIGN, SUPPLY AND INSTALL-TURNKEY CONTRACT OF PRE-ENGINEERED LIGHT GAUGE COLD FORMED GALVANIZED STEEL STRUCTURES FOR EDUCATIONAL FACILITIES IN DISTRICT MANSEHRA

- 1. The Employer Chief Engineer Reconstruction PERRA invites sealed Bids in accordance with Single Stage Two Envelope Bidding Procedure for Contract No. PERRA/Mansehra/232/2009 on Turnkey Basis from eligible firms licensed by the Pakistan Engineering Council (PEC) in category C2 and above for reconstruction of 29 schools in UC Devli Jabbar, Bhogarmang, Shaukat Abad & Shamdhara. A foreign bidder is entitled to bid as per provisions of PEC bye-laws. Firms/Manufacturers desirous of participating in the above Bid must fulfill the following qualifications:
  - a. In case of Joint Venture, the JV must collectively satisfy the prescribed qualification criteria, however, the lead partner shall meet not less than 40% of all qualifying criteria.
  - b. The bidder participating in this bidding must qualify the following:
    - i. has completed at least one turnkey contract, with a minimum value of Rs. 200 Million during the last five years;
    - ii. has designed, supplied and installed at least one similar facility, during the last five years; and
    - iii. has an average annual turnover during the last five years, equal to or more than Rs. 200 Million.
- 2. The construction period for each Project is 270 days.

A complete set of Bidding Documents may be purchased by an interested Bidder or by authorized representative of the Firm/Principal on submission of a written application to the above office and upon payment of a non-refundable fee in the form of Pay Order/Bank Draft in favor of NESPAK for Rupees Two Thousand Five Hundred Only (Rs. 2,500/-) for each Bidding Document.
- 5. All Bids must be accompanied by a Bid Security amounting to Rs. 2,175,000/- (Ruppes two million one hundred and seventy five thousands only) in Pak Rupees in the form of Deposit at Call or a Bank Guarantee issued by a Scheduled Bank of Pakistan in favor of the Employer, and must be delivered in the office of Director General (Monitoring and Evaluation) Wing, ERRA Headquarter, Murree Road, Opposite Margalla Town, Islamabad at or before 1500 hours on 23 Dec 2009. Technical Bid will be opened at 1530 hours on the same day in the presence of bidders' representatives who choose to attend at the same address.
- 6. A Pre-Bid Meeting will take place at 1500 hours on <u>14 Dec 2009</u> in the office of General Manager/ Head ER Division, NESPAK.
- 7. The prospective bidders are advised to visit and examine all the school sites in consultation with respective education departments; at their own cost & arrangement by taking all requisite security precautions, preferably before Pre-Bid Meeting Date.
- 8. Technical Bids will be opened first immediately after the deadline in the presence of bidder's representatives who choose to attend. At the end of the evaluation of the Technical Bids, the Employer will invite bidders who have submitted substantially responsive Technical Bids and who have been determined as being qualified for award to attend opening of the Price Bids. The date, time and venue of opening of Price Bid will be intimated separately.
